Students' Feedback 1. For the design and review of the syllabus was discussed with the students in the open house. 2. On clarity, relevance, learning, applicability and coverage of syllabus, wherein about 3 to 4% students shown strong disagreement.	The students' feedback is considered and it will be incorporated at the time of revision of courses after discussion in PRC. In the students open house meeting and at the time of class room discussion, clarity, relevance, learning, applicability and coverage of syllabus points were discussed in detail and the doubts were cleared.
Teachers suggested courses/topics. 1. Concepts of CPU scheduling and memory management - examples and programs can be added 2. Specific courses focused on new business trends and business thinking like RideShare Applications	The BBA(IT) students are not expected to have a thorough knowledge of CPU scheduling and memory management; hence, these topics are not covered. RideShare application will be discussed in the PRC and included in the syllabus if required.
Alumni suggested courses/topics such as SAP, Information Security, Courses related to compliance, AML/KYC, Investment banking, Business Communication, Stakeholder Management, Strategic Decision making, People Management, and Cyber Security.	Information Security, Business Communication, and People Management courses are already in the Programme Structure. Cybersecurity is also covered in the Information security course. Compliance is taught as a part of the ITRC course. Business Policy and Strategy is a course which covers Strategy related concepts. Banking operations cover topics like KYC/AML and investment banking.


